

Prom Dress Guidelines

- Floor length formal gowns- no more than ½ inch off the floor
- No SHORT dresses
- NO HUGE Side CUTOUTS
- Strapless Dresses must fit securely
- Back of Dresses may not be SUPER LOW CUT
- No slits (*front, back, or side*) above fingertip length in a standing position. This is mid-thigh.
- No EXCESSIVE CLEAVAGE
- No HIGH-LOW dresses
- Front of Dress CANNOT have cutouts that exposes skin underneath
- Entire gown must be a non-sheer/non see through fabric

Two-Piece Dress Guidelines

- May not be strapless
- Maximum 2" of torso can be shown
- In addition to all other non-permitted guidelines

Boys Prom Attire:

- Formal Only, Options:
 - Tuxedo
 - May include vest or cummerbund
 - Dress Suit
- EITHER option must INCLUDE
 - Matching jacket & pants (no khaki pants/blazer)
 - Necktie or Bow Tie
 - BUTTON UP dress shirt
 - o Dress shoes, or nice/clean tennis shoes
- NO TURTLENECKS IN PLACE OF A BUTTON UP SHIRT
